Re: Spring 2019 General Education Requirements.

The Curriculum Committee has reviewed all of the Spring 2019 General Education recommendations submitted by the General Education Governance Committee in their January 30, 2019 memorandum. All of the course recommendations have been approved. However, the committee would like to provide you with the following feedback on some of the course submissions.

There is a good case for **English 100** to fulfill the "Foundations of Society and Culture: Historical Analysis" category.

Public Affairs 30, Religion 55, and Middle Eastern Studies M50CW/Anthro M67W are all foundational courses with a broad scope and are eminently well-suited to lower division.

Ancient Near East M60/History M60 and Musicology M95/Jewish Studies M70 are on narrower topics, but because they are both on highly significant historical periods/events, they also make good GE courses.

Theater 98TA and **98TB** are great examples of CUTF courses that explore a broad and foundational topic that is well suited to lower division.

In the case of Italian 98T, as has been the case with many CUTF courses in the past, it would have been helpful to have an explanation of why this course is better suited to lower division than to upper division. The Renaissance is a highly significant period in European history, so in this sense the course has some points of similarity with GEs like Ancient Near East M60 or Musicology M95 above, but those courses make a much better case for the broad significance of the topic. As a course that seeks to counteract standard narratives of the Renaissance, Italian 98T seems to assume a familiarity with the Renaissance that many undergraduates at UCLA probably do not share.
