Re: Winter 2019 General Education Requirements.

The Curriculum Committee has reviewed all of the Winter 2019 General Education recommendations submitted by the General Education Governance Committee in their October 29, 2018 memorandum. As we previously indicated to you and the Registrar's Office, all of the course recommendations have been approved. However, we wanted to follow up with you regarding some of the specific course recommendations—specifically the Collegium of University Teaching Fellows (CUTF) course recommendations—and to provide you with specific feedback on each course.

Anthropology 98TA: Worlds of Well-Being: Anthropological Perspectives on Health and Happiness. The course has a general topic that is appropriate both as a lower-division course and as a General Education course.

Anthropology 98TB: Cultures of Mental Health in the US. The course has a general topic that is appropriate both as a lower-division course and as a General Education course.

Anthropology 98TC: Animals in Anthropology: Killer Bees, Mutant Mice, and Heroic Horses. While the topic is very specific, it is appropriate as a lower-division course and as a General Education course.

Chemistry 98T: Clean Energy from the Ground Up. The course has a general topic that is appropriate both as a lower-division course and as a General Education course.

Education 98T: Diversifying University Through Internationalization: New Directions, Challenges, and Opportunities. The course has a general topic that is appropriate both as a lower-division course and as a General Education course.

Ethnomusicology 98T: Musical Activism as Political Contestation. Appropriate both as a lower-division course and as a General Education course, but the amount of reading and writing for this course is bit light for a 5-unit course.

Film TV 98T: Video Games, Aesthetics, and Politics. The course has a general topic that is well-suited to a lower division course.

French 98T: Decolonizing French Food through Literature and Film. As the course description suggests ("students will examine the intricate interplay of art and culture, society and politics that has comprised French colonialism and its aftermath" and will be exposed "to influential theoretical texts on postcoloniality") the course appears to be directed to upper division students in the humanities. It is difficult to imagine a first year student with no exposure to postcolonialism who would not benefit greatly from taking another more basic lower division course before this one. Approved with reservations.

Gender Studies 98T: The Violence of Settler Colonialism and Indigenous Feminist Self-Representation. This course also appears to be eminently suited for upper division rather than lower. There seems to be little effort in the syllabus to introduce students to basic concepts that might help them make sense of the material. Students would benefit greatly from taking another more basic lower division course before this one. Approve with reservations.

Islam M50: Islam and Other Religions. The course has a general topic that is well-suited to a lower division course.

Japanese 98T: Pilgrims, Patrons, and the Sacred: Ritual Participation in Japanese Religions. While the topic of the course is fairly specific, it uses early modern Japan as a case study to explore key concepts in religious studies such as "ritual" "pilgrimage," etc, and dedicates the first few weeks to introducing the basic concepts of the course.

Middle Eastern Studies M25W: Middle Eastern Cities. The topic of the course seems curiously specific for a lower division course, but it does include some examination of basic concepts at the beginning of the course.

Musicology 98T: Prince and the (1980s U.S. Cultural) Revolution. The topic of this course is very specific for lower division. The topic is relatively accessible, but more effort could have been made to introduce basic concepts at the beginning of the course. Approved with reservations.

Psychology 98T: The Science of Empathy; How Empathy Leads Us to Help—and Hurt—Others. Like many of the other 98T courses, this course seems very specialized for lower division. Approved with reservations.

World Arts 98T: Curating and Contemporary African Arts. This is a rather rough proposal with numerous typos, but it is on a general topic and relatively well suited to lower division.

We hope that you will continue to work with those involved in the administration of the CUTF program to refine their curricular proposals and examine the appropriateness of the topics and types of credit requested for each these courses.
